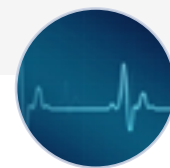
New Models to Deliver Healthcare

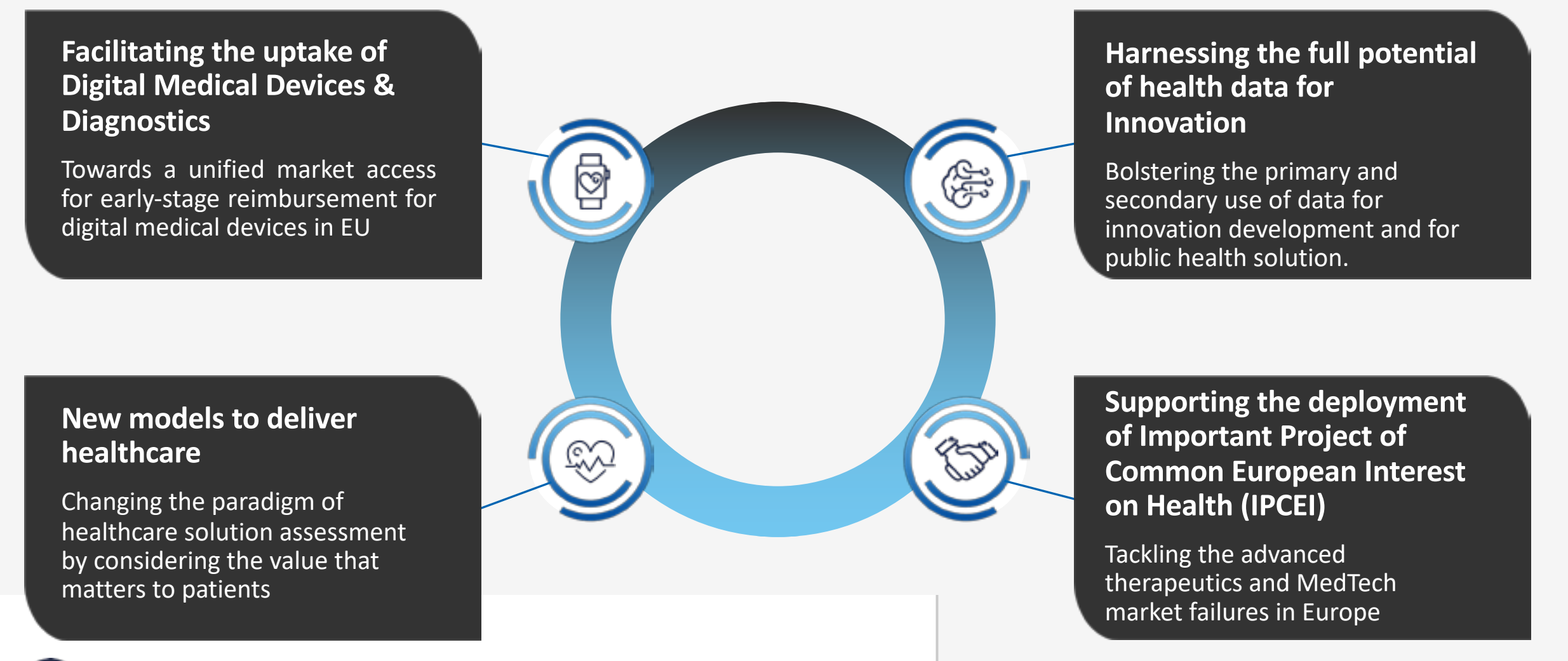


Supporting the Deployment of Important Project of Common European Interest in Health (IPCEI) to address Market Failures
