


The BeWell skills strategy





The LSP for the Health Ecosystem

The Pact for Skills: Large-scale Partnership for the health ecosystem (henceforward called “Partnership”) is the **Partnership dedicated to bringing together all health stakeholders involved in the field of skills.**

The Partnership will engage education and training providers, VET and HE, key healthcare professional organisations industry stakeholders (medical technologies & devices and pharmaceutical), public authorities (regional and national), social partners, labour market actors, and research institutions.

The BeWell consortium, in particular EUREGHA and EHMA, will coordinate and manage the Partnership (Partnership Coordination Team) until the end of the project in June 2026.

The Partnership Manifesto - The starting point

- The **health workforce represents a significant share of the European workforce**, with almost 15 million people who work in health occupations.
- The sector continues to face **considerable workforce challenges**, exacerbated by the effects of the COVID-19 pandemic and a constantly evolving environment.
- **Urgent need for health workforce upskilling and reskilling**, while facing **complexities** that make this activity a rather difficult exercise, *including rapid transformation of the sector, shortages, resignations, difficult work conditions*.
- **Digital transformation** - developing skills in health to support the sector's transformation is essential. Nevertheless, the health sector is lagging behind when it comes to seizing digital opportunities and providing adequate training.
- **Green transformation** - Health workforce should also be resourced and trained to engage with the green transition towards more environmentally sustainable health provision which respects the 'one health' principles.
- **The constantly evolving environment demands other skills to be developed in tandem with green and digital:** logistics and management skills, communication and other skills such as patient-engagement, leadership and advocacy, collaboration and interdisciplinary capacity.
- **Crucial need to address complex transition from education to labour market:** skills mismatches, strong need for life-long learning and to identify a specific **skill-mix** (digital, green, other)
- **Avoid excessive burden on a health workforce** dealing with **shortages** and **high levels of pressure** on employees' mental health




